SPECIAL VOLUNTARY DISCLOSURE PROGRAM

Special Voluntary Disclosure Program (SVDP) was announced by The Honorable Minister of Finance Malaysia, YB Lim Guan Eng during his Budget 2019 speech on 2 November 2018, SVDP allows taxpayer to voluntarily declare any unreported income, including income derived and remitted into offshore bank accounts.

Under the SVDP, any income reported from 3 November 2018 to 30 June 2019 will be subjected to reduced penalty rates. The penalty rates will be increased substantially after the SVDP program (refer to chart 1).

The program is one of the government's tax reform efforts to reduce the existing tax gap, minimize the tax leakage and increase tax collection. Furthermore, it is in line with the implementation of Common Reporting Standard (CRS) on 30 September 2018 whereby participating countries will receive resident taxpayers' financial information from other foreign tax administration.

What can be disclosed under the SVDP ?

- Income Tax
 - Income not previously declared
 - Expenses over claimed
 - Expenses not allowable
 - Relief / deduction / rebate over claimed
- Real Property Gains Tax (RPGT)
 - Gains on disposal of real properties and shares in real property company ("RPC")
- Stamping of instruments not previously stamped

How to disclose?

Categories of voluntary disclosure	Disclosure mechanism
Not Register with IRB	Register an income tax number. Submit manual return or e-filing*
Registered but not submit tax return	Submit manual return or e-filing*
Submitted but not report correct income or gains on disposal of asset	Submit written declaration via letter or email
Present an instrument for stamping > 6 months from the stamping period (30 days from the execution date)	Submit stamped instruments manually or online

For corporate – e-filing is mandatory effective from YA 2014. Submission of supporting documents is not compulsory

Advantage of SVDP ?

- No further enquiry on income disclosed**
- Final and conclusive: No subsequent audit
- Taxpayer still can appeal

*** Except in the case where additional information from 3rd party shows that the income has not been correctly reported and it is within the taxpayer's knowledge.*
