

How do these policy affect entrepreneurs ?

- To mitigate the cost burden on small-and medium-sized enterprises (SMEs) caused by Covid-19 and subsequent movement control order (MCO), especially for companies that employ foreign workers.
 (这项援助主要是帮助中小型企业减少成本负担因Covid-19所造成的影响, 特别对于有雇佣外籍员工的公司)
- Government encourages to have negotiations between employers and workers on employment terms during the MCO period, including
 - Pay cuts
 - Unpaid leave

Extension levy fees

Foreign workers are allowed to work in Malaysia on a yearly basis up to **10 years** (外籍员工只允许在我国工作10年)

> They could extend their employment duration for who had been employed for 10 years (可延长工作期限)

> > RM10,000 for a three-year renewal (maximum)
