What is PAID-UP CAPITAL?

什么是实缴资本/已收资本?

- ❖ Actual amount of funds that are received by the Company from its Shareholders 公司从股东收到的实际资金/金额
- ❖ In return, the Company will allot shares to the Shareholders according to the amount paid respectively otherwise known as, Allotment of Shares (normally Ordinary Share) 本公司将根据股东所支付的款项向股东发行股票(通常为普通股份)

How to INCREASE PAID-UP CAPITAL?


Cash / Cheque 现金/支票

❖ Present the bank-in slip that shows the actual amount of capital injected into the Company's account by the Shareholders 银行发票显示股东实际注入公司帐户的资金总额

Consideration other than cash 现金以外的对价

- ❖ Present the amount owing to Shareholders in the Company's Management Accounts of Audited Report 公司管理账户或经审计报告中显示公司归还股东款项可用来作为公司资本
- ❖ Shareholders must agree to capitalize the amount as paid-up capital 股东同意将公司归还的款项化为实收资本





However, Do Take Note That...... 不要掉入实收资本的误区!

- ❖ Sales or revenue cannot be used as paid up capital to the Company 销售或收入不能用于向公司缴足资本
- ❖ As Sdn. Bhd. is a separate legal entity, Directors/Shareholders can not treat the Company's Account as a Personal Account 有限公司是独立的法人实体,董事或者股东无法将公司帐户视为个人帐户
- ❖ Proof or evidence must be provided to show the relevant amount received by the Company 必须提供证据以证明公司收到的相关款项



Steps to Increase Paid-Up Capital

Company Secretary will prepare the board and Members' resolution and relevant documents. The board and Members' resolution and relevant documents will be signed by the Directors and Shareholders.

Company Secretary needs to lodge the Return of the Allotment of Shares (Form Section 78) and Register of Members (Form Section 51) within 14 days in MYCOID system. Paid-up capital is considered successful once the submission for Allotment of Shares becomes approved and is updated by SSM.

Form Section 78 and Section 51 will be generated in MYCOID to show the current paid-up capital.

Did You Know?

您知道吗?

With effect from 31 January 2017, Form 24 has been replaced with Section 78 under Companies Act, 2016.

从1月31日2017年起, 在2016年公司法令下Section 78将会取代Form 24。

However, Form 24 remains valid for Companies that were incorporated under Companies Act, 1965.

但是, Form 24对于1965年公司法令成立的公司仍然有效。

Companies are no longer required to state their Authorized Capital under Companies Act, 2016. In other words, Companies' paid-up capital increment will no longer be restricted to its Authorized Capital.

根据2016年公司法令,增加缴足资本不再受限于授权资本。

Company that wish to increase its paid-up capital for the first time, is required to submit Form Section 76 showing that the document (Allotment of Shares) has been approved by the Company to SSM within 14 days.

公司第一次增加实收资本时,必须提交Section 76,显示该文件已获得公司的批准,可在14天内向商业局配发股份。







Who Can Become Shareholders?

Any individual can become shareholders as long as he/she is 18 years old and above.

Any solvent corporate body.
